

^{*} Tax legal cases are not included; hence they are handled by Tax.


Legal - Contracts

Comparing **2023 vs 2024** (Jan-Oct), the <u>lead-time decreased by 60%</u> (40 to 16 days), mainly due to the following factors:

- Unifying and simplifying HCP's contract templates
- Removing the requirement for **5** signatures and **2-witness signatures**
- Introducing a **digital legal stamp**, which eliminated one step of the process
- Increasing LoB's autonomy without legal approval from \$100K\$ to \$200K\$


In contrast, the <u>number of contracts</u> <u>increased by 59%</u>, largely influenced by Marketing & Medical contracts associated with Wegovy launch strategy.

The actions and initiatives implemented by legal department efficiently managed an increasing of contracts associated with the Wegovy launch, while also reducing the process lead-time.



Flow Project

The project targeting to reduce the complexity and process lead-time aiming to accomplish the OKR #3.

Actions and initiatives implemented by legal department efficiently managed an increasing of contracts associated with Wegovy launch, while also reducing the process lead-time 60% (from 40 to 16 days).


The main Legal deliveries to the project was:

- Creation of Clinical Research Contract Playbook (Portuguese and English)







Compliance – Initiatives

Compliance + P&O

Monthly meeting with P&O to discuss initiatives, concerns, gaps, and opportunities for improvement.

Obulo Project

A 6 months project in collaboration with Commercial Effectiveness and P&O to identify points of improvement in the information provided by IQVIA via OneKey.

A platform was hired and a total of 29,495 physicians were verified, aiming to ensure more consistent information in the data available in IO Engage.

Compliance + Internal Controls

Bi-monthly meeting with Internal Controls focused on audit action plan, risks, gaps in the process, new controls, and monitoring of activities.

Compliance Partners

Implemented in the second half of the year, this group is made of 16 employees.

In a monthly basis, meetings are held to strive Business Ethics in Novo Nordisk.

The group has been discussed subjects such as Compliance best practices, anticorruption, Hotline, Concur and Corporate card.
